Details of the goods are in the Technical Specifications in the Tender Documents. Tenderers shall quote for goods in the required quantities as indicated above.

- 3. Tendering will be conducted through the **International Competitive Tendering (ICT)** procedures specified in the **Public Procurement Act, 2003, (Act 663)**, Amendment Act, 2016, (Act 914), and in the Guidelines of the Public Procurement Authority of the Republic Ghana.
- 4. Interested eligible Tenderers may obtain further information from the Intercity STC Coaches Limited and inspect the Tender Documents from the Procurement Unit of the Intercity STC Coaches Limited on working days, from Monday to Friday between 09:00 to 17:00 Hours local time at the address (1).

- 5. The following attachments/conditions are to be met by all prospective Tenderers:
 - > Statutory Business Registration Certificates
 - Previous experience in supplying buses/coaches within the Republic of Ghana and/or Africa
 - Possession of valid Manufacturers' Authorization, if it is not the manufacturer
 - > Submission of Brochures and Catalogues confirming the technical specifications
 - > Submission of a comprehensive/responsive Financial Offer in accordance with requirements contained in the Tender Document
- 6. A complete set of tender document, in English, may be purchased by interested Tenderers on the submission of a written application to the address (1) below and upon the payment of a non-refundable fee of One Thousand Five Hundred Ghana Cedis (GHS 1,500.00) or US\$300.00 (Three Hundred United States Dollars). The method of payment shall be by Cash in Ghana Cedis or a Convertible Currency/Cashier's Cheque in favour of Intercity STC Coaches Limited.
- 7. Tenders must be addressed and delivered to the address (1) on or before Thursday 23rd January 2020 at 10:00 Hours GMT. Tenders shall be valid for a period of 120 days after the deadline of Tender submission. A Tender Security of value indicated in table 1 must accompany all Tenders. Late Tenders will be rejected.
